Staff have been working on the school improvement implementation and preparation for an external visit in 2017-2018. School will dismiss at 1:00 p.m. on Wednesday, December 21, and resume on Tuesday, January 3. A teacher inservice is planned for Monday, January 2. The annual ESU 15 and 16 Board Member Workshop has been scheduled for January 25. Mr. Porter thanked Board Member Steve Daffer for his 12 years of service to the district.

Principal Latta reported on elementary attendance at "Rave On", a Buddy Holly program, courtesy of the Sherwood Foundation, the "Alice in Wonderland" ballet production, and a Native American Life experience by Robb and Mary Jo Overton. Preschool applications are due December 15, and the Christmas program is December 19.
